#### **Foreword**

While we've always recognised the benefits of owning a pet—be that through companionship, staying active or teaching our children responsibility—we've been slow to understand the enduring value of the human—animal bond for elderly people.

Improving awareness and influencing policy in this space are core tasks of Companion Animal Network Australia (CANA). Our Pet Friendly Aged Care online resource is leading the way in starting the conversations we need to have around pet ownership into old age.

To complement expert opinion and international data, CANA established a framework to survey the views and experience of Australians. These surveys will continue to collect responses but are already offering statistically sound results.

It is our hope that the voices of our elderly, along with those of aged care staff and the wider public, will open hearts and minds to the mental and physical benefits of lifelong pet ownership.

#### Who is CANA?

Through its division Pet Friendly Aged Care, Companion Animal Network Australia (CANA) is working to preserve the bond between older Australians and their furry, finned and feathered friends.



Pet Friendly Aged Care was established to highlight the often-catastrophic emotional harm caused when older people are forced to give up their pets upon moving into an aged care home, and to provide a more practical way forward.

#### Our goals are to:

- Increase the number of pet-friendly aged care support services to prevent animals from being euthanised or surrendered to shelters
- Maximise the physical and emotional health of our animal-loving older people
- Promote the social benefits for communities who welcome pets.

#### Results overview

It is always exciting to hear in people's own voices how their relationship with a pet impacts their lives, and how these relationships are being supported within the aged care support system, both community and residential based.

The survey data collected broadly reflects the geographical distribution of population across Australian states and territories, with a response bias from Queensland. This is not unexpected, as there is a pets and older persons project in place there.

Reports from older persons reflect the known positive impacts of pets including feeling loved, company, providing meaning and purpose to daily lives, exercise opportunities, positive mental health benefits (laughter, joy, socialisation, calming), tactile engagement and sense of security and safety.

While there were three times more dogs reported than cats, and a small number of birds and other species, the positive impacts of human animal relations were reported across all species.

Some negative factors were noted, such as the physical difficulties of older people caring for aging pets. Yet, even with these challenges, people saw the relationship with a pet as, on balance, being beneficial.

At times people expressed solidarity with ageing animals—they are considered family members who have shared family stories over many years and, hence, not to be discarded as though they were inanimate meaningless objects. This is important, as it indicates the potential to inflict moral injury on some older people is high when forcing them to relinquish loved animals.

I commend the enclosed findings as a powerful and meaningful contribution to our better understanding of the role pets play in the lives of older people.

## Methodology

The three surveys that have generated the data that follows were designed to capture opinions specific to the experiences of older people, aged care staff, aged care facility operators, in-home carers and the wider public.

In designing the surveys, CANA asked people from the industry, home care, residential care and the broader aged care sector for the kind of information they'd like to gather.

The surveys can be completed online and are available at our Pet Friendly Aged Care website. Each survey takes around 2minutes to complete.

Awareness of the surveys has been primarily built through the CANA network of companion animal member agencies across Australia.

## CANA General Aged Care Survey Results in detail



**What did we find?** Participants were invited to select their top 3 benefits of pet ownership for people in aged care settings, with physical and mental health topping the list.

**What does it mean?** As our population ages, solutions to maintaining a high quality of life include finding ways to help ageing people retain their pets.



What did we find? Education among aged care providers and a lack of funding to facilitate design changes are believed to be the main barriers to pet ownership in aged care facilities.

**What does it mean?** Much work is to be done to increase awareness of the physical and emotional benefits to residents derived from pet ownership, while supportive funding models will reduce the burden of design changes to accommodate pets.





## CANA Residential Aged Care Survey Results in detail



**What did we find?** The vast majority of aged care facilities do not permit pet ownership, with numbers that closely reflect those of previous reports.

**What does it mean?** Limited progress is being made in maintaining the human-animal bond in aged care facilities, although visiting and shared pets are providing residents of some facilities with valuable pet contact.
